In consideration that GSSF and the Host allow the Participant to act as a Range Officer and/or to observe and/or to compete in the Match, the Participant hereby irrevocably and unconditionally releases GSSF and the Host, and their agents, officers, directors, trustees, assigns, employees, and members from any and all claims, rights, demands, and causes of action, whether in contract, tort or otherwise, which the Participant has or may have, whether now or in the future, arising out of any contact, occurrence, event, act or omission which may occur as a direct or indirect consequence of the Participant's attendance or participation in the Match and any and all other matches, sponsored by, held at the direction of, or in any way connected with GSSF, that the Participant may attend in the future.

Participant agrees to wear appropriate eyesight protection at all times while the Match is underway including when Participant is not in the immediate vicinity of any live firing of firearms. Participant agrees to wear appropriate hearing protection while the Participant is in the vicinity of any live firing of firearms.

If the Participant is acting as a Range Officer and/or competing in the Match, the Participant hereby warrants that prior to his or her participation in the Match, that he or she has at a previous GSSF match or will, prior to participating in this Match; examine a "Competitor Briefing" document supplied by GSSF. While participating in the Match, the Participant agrees to abide by the Safety and Match Procedures promulgated in the "Competitor Briefing" document.

Participant hereby certifies that he or she is not: Legally inhibited from handling or discharging firearms. That if the Match is being held in a State that limits the age whereby a Participant may handle or discharge a firearm that Participant is of or over that age limit. That Participant is not under indictment or information for, or has been convicted of, a felony or other crime for which a judge could imprison or has imprisoned Participant for one year or more, including probation time. If so convicted, where such conviction has not been expunged from Participant's records by the courts. That Participant is not a fugitive from justice. That Participant is not an unlawful user of or addicted to, marijuana or any depressant, stimulant, or narcotic drug or any other controlled substance. That Participant has never been adjudicated mentally defective, which includes having been adjudicated as incompetent to manage Participant's own affairs. That Participant has never been committed to a mental institution. That Participant has never been discharged from the Armed Forces under dishonorable conditions. That Participant is not subject to an order restraining Participant from harassing, stalking, or threatening Participant's child, or an intimate partner of Participant, or child of such partner. That Participant has never been convicted in any court of a misdemeanor crime of domestic violence. That Participant has never renounced United States citizenship. That Participant is not an alien illegally in the United States.

The Participant understands that GSSF personnel may take photographs of Match activities, and that the Participant may be included in such photographs. If GSSF subsequently wishes to utilize such photographs in its various publications, the Participant hereby consents to such publication of his or her likeness.
